Vehicles as Weapons of Terror

On July 14, 2016, Tunisian-born [Mohamed Lahouaiej-Bouhlel](#) drove a 19-ton truck into a crowd celebrating Bastille Day at Nice's Promenade des Anglais, killing 86 people and wounding more than 430 others. [ISIS](#) claimed responsibility for the terrorist attack two days later, calling Lahouaiej-Bouhlel a "soldier of the Islamic State."¹ The attack in Nice, though not the first of its kind, was the deadliest modern vehicular terrorist attack² in Europe, launching a wave of terrorist and ISIS-claimed vehicular attacks around the world. Since the Nice attacks, CEP has documented

major vehicular incidents in Vienna,³ Ohio,⁴ Berlin,⁵ London,⁶ Antwerp,⁷ Stockholm,⁸ Paris,⁹ Barcelona,¹⁰ Edmonton,¹¹ and New York.¹² On August 14, 2018, an attacker struck pedestrians and bicyclists in London before crashing his car into security barriers outside the Houses of Parliament, leaving three people wounded.¹³

The 2016 Nice attack set off a wave of vehicular terrorist attacks in autumn of that year, which collectively left 12 people dead and 67 others wounded. In September 2016, an assailant drove his car at shoppers in Vienna's Favoriten district while shouting "Allahu Akbar," leaving no injuries.¹⁴

In November 2016, Somali-born [Abdul Razak Ali Artan](#) carried out a car and knife attack at Ohio State University, wounding 11 people.¹⁵ In December 2016, Tunisian-born [Anis Amri](#) charged at pedestrians attending the Christmas Market in Berlin, killing 12 people and wounding 56 others in an attack claimed by ISIS. Footage released by the ISIS-affiliated Amaq News Agency showed Amri pledging allegiance to the group's leader, [Abu Bakr al-Baghdadi](#), vowing "we will slaughter" the "crusaders who are shelling the Muslims every day."¹⁶

CEP has documented at least 67 vehicular terrorist attacks since 2006, collectively resulting in the deaths of at least 210 people and the injury of at least 1,152 others.

Vehicular attacks continued into 2017 and 2018, leaving at least 34 people dead and more than 240 wounded. On March 22, 2017, terrorist assailant [Khalid Masood](#) killed five people and wounded 50 more during a vehicle and stabbing attack in London.¹⁷ The following day, a similar attack was thwarted in Antwerp, Belgium.¹⁸ On April 7, another assailant carried out a suspected terrorist attack, this time in Sweden, hijacking a truck and careening into crowds of pedestrians at the Ahlens Mall in Stockholm, killing four people and wounding 15 more.¹⁹

On the evening of June 3, 2017, three assailants drove a van at high speed into crowds on the London Bridge and exited the vehicle to stab other pedestrians at the nearby Borough Market.²⁰ The attack, claimed by ISIS, left eight people dead and 48 others wounded, and followed a call by ISIS on May 17 to carry out terrorist attacks in the United States, United Kingdom, and European

Union using knives and trucks.²¹ On June 19, 2017, an assailant drove at a crowd of worshipers near a mosque in north London, leaving at least eight people wounded.²² Later that day, an armed assailant rammed his vehicle at a police car on the Champs-Elysees street in Paris, seriously injuring himself but leaving no other casualties.²³

On August 17, 2017, a van was deliberately driven into a crowd of tourists in Las Ramblas, a tree-lined street in the center of Barcelona. The attack, claimed by ISIS, left 16 people dead and 120 others wounded.²⁴ On September 30, 2017, an assailant launched two vehicular terror attacks in Edmonton, Canada, collectively injuring five people. In the first attack, the assailant used a car to ram into a police officer before exiting the car and stabbing him. The assailant later used a truck to ram into pedestrians, injuring another four people. An ISIS flag was later found in the suspect's vehicle.²⁵

Vehicular attacks are not a new phenomenon. Terrorists have carried out car-ramming attacks for more than a decade, in locations ranging from North Carolina²⁶ to Jerusalem,²⁷ Tel Aviv,²⁸

Quebec,²⁹ Dijon,³⁰ Nantes,³¹ the West Bank,³² Graz,³³ and Xinjiang.³⁴ The uptick in vehicular attacks in recent years, however, appears to have been in large part inspired by ISIS's explicit calls to employ cars as weapons. And while groups such as ISIS and al-Qaeda have long called for vehicular attacks as a tactic to sow fear, since 2016, vehicle attacks have also become a tool against protesters. For instance, an online propaganda campaign by the far right has legitimized vehicle

attacks against protesters as part of a concerted effort to diminish their causes.³⁵ Members of the far left have also utilized the tactic in response to counterprotests.³⁶ Vehicle attacks have also been a consequence of other criminal activity. On November 21, 2021, for example, an SUV sped through a Christmas parade in Waukesha, Wisconsin, killing at least five and wounding at least 40. Investigators did not link the incident to terrorism or extremism and charged the driver with multiple counts of homicide.³⁷

In May 2017, the U.S. Transportation Security Administration (TSA) issued a warning to truck and bus companies urging companies to watch out for potential vehicular terrorist assailants and listing more than a dozen car-ramming attacks since 2014 that have collectively killed more than 170 people.³⁸ As the TSA wrote in its memo, terrorist groups will likely continue to encourage “unsophisticated tactics such as vehicle-ramming” since these types of attacks are difficult to prevent and “could inflict mass casualties if successful.”³⁹

Al-Qaeda, ISIS, and Hamas Call for (and Claim) Attacks

Terrorist groups like al-Qaeda, ISIS, and Hamas have long called for—and claimed responsibility for—vehicular terrorist attacks. Al-Qaeda’s second issue of *Inspire* magazine, released in October 2010, contained an article calling for vehicular attacks and referring to a pickup truck as a potential “mowing machine” that can be used to “mow down the enemies of Allah.”⁴⁰ *Inspire* editor-in-chief Yahya Ibrahim urged al-Qaeda followers to “[g]o for the most crowded location” and “pick up as much speed as you can” in order “strike as many people as possible.”⁴¹ An FBI memo released in December of that year noted the emerging danger from vehicular attacks, which may

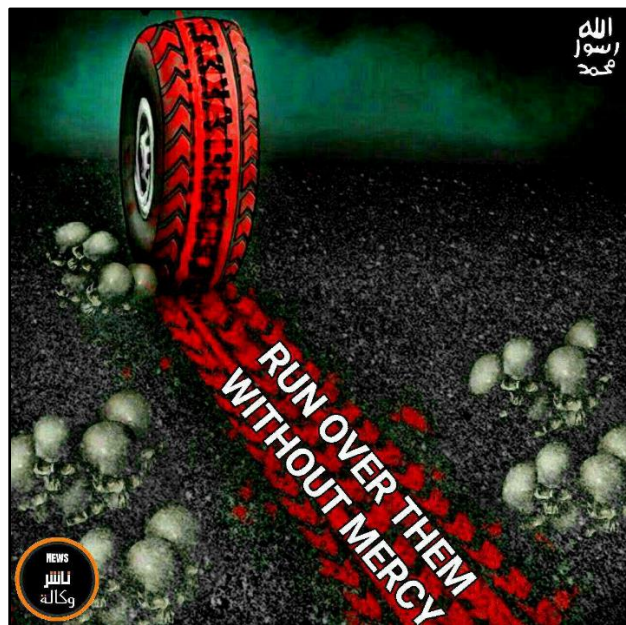

allow terrorists with “limited access to explosives or weapons” the ability to conduct an attack with “minimal prior training or experience.”⁴²

Following the October 31, 2017, truck-ramming attack in New York City, several old images praising vehicular and other attacks reappeared on pro-ISIS channels on the encrypted messaging service Telegram. In addition, ISIS propaganda calling for vehicular attacks was accessible online the same day of the attack.



An old ISIS propaganda image from Nashir, a news organization affiliated with the group, recirculated on a pro-ISIS Telegram channel on October 31, 2017.

On October 16, 2017, an Internet user uploaded to the U.S. Internet Archive an ISIS video instructing how to carry out a ramming attack. The video is a 26-second segment of the longer video, “*We Will Surely Guide Them to Our Ways*,” which features the self-identified American fighter Abu Hamza Al-Amriki, who encourages lone wolf attacks with knives and motor vehicles. The video also features several short clips of U.S.-based locations, including New York City’s Times Square. The video was originally released on May 17, 2017.

In September 2014, ISIS spokesman [Abu Muhammad al-Adnani](#) issued a call to kill non-believers using any means at their disposal. “[S]ingle out the disbelieving American, Frenchman, or any of his allies,” he said. “Smash his head with a rock, or slaughter him with a knife, or run him over with your car.”⁴³ In November of that year, French foreign fighter [Abu Salman al-Faranci](#) appeared in a video reiterating ISIS’s call for followers—particularly in France—to carry out domestic attacks if they could not join ISIS abroad. As Faranci said to his viewers: “Terrorize them and do not allow them to sleep due to fear and horror. There are weapons and cars available and targets ready to be hit.”⁴⁴

In mid-November 2016, ISIS’s third issue of online magazine *Rumiyah* included an article calling for its followers to carry out vehicle attacks. The article specified the ideal type, weight, and speed of a car needed for terror purposes, and encouraged attacks on “large outdoor conventions and celebrations, pedestrian-congested streets, outdoor markets, festivals, festivals, parades[, and] political rallies.”⁴⁵ Later that month, Somali-born Abdul Razak Ali Artan carried out a car and knife attack at Ohio State University, wounding 11 people.⁴⁶

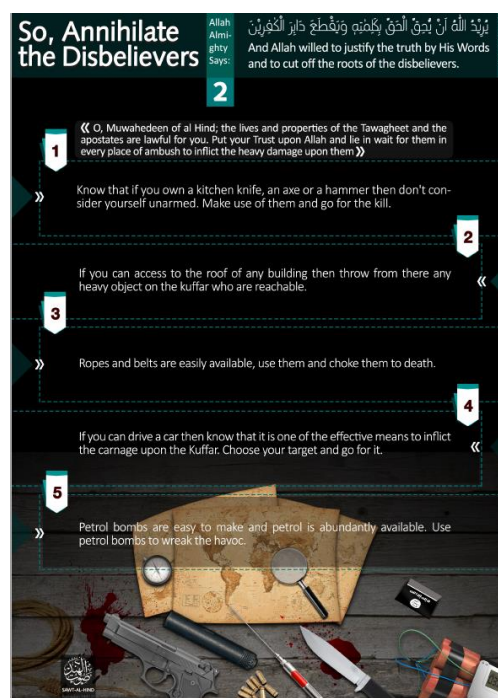

Following the wave of vehicular terrorist attacks in 2016 and 2017, ISIS has continued to issue calls to violence and warnings of additional car-ramming attacks. On May 17, 2017, the group released a video threatening attacks in the United Kingdom, Europe, and the United States, especially in New York, Las Vegas, and Washington, D.C. ISIS has also threatened and encouraged vehicular attacks on gay pride parades.⁴⁷ In June 2017, an account operating under the name of ISIS’s Nashir agency released a renewed call for ISIS supporters to “[r]un over people by vehicles and [c]ut off their necks in any time [sic].”⁴⁸ In April 2020, the third issue of pro-ISIS online magazine *Sawt al-Hind* (Voice of India) issued a new call for vehicular attacks as one of multiple inexpensive and easy ways to attack non-believers.⁴⁹

ISIS and al-Qaeda are not the only terrorist groups to urge or claim credit for vehicular terrorist attacks. One of the first documented vehicular attacks was carried out by an unaffiliated Iranian-American, who wounded nine people at the University of North Carolina in 2006.⁵⁰ As the assailant Mohammed Reza Taheri-azar told investigators, he had had carried out the attack in an

effort to punish the U.S. government and “avenge the deaths or murders of Muslims around the world.”⁵¹

A slew of car-ramming attacks have also been carried out by Palestinian assailants in Israel and the West Bank. In November of 2014, Hamas and other Palestinian terrorist groups—including the [Palestinian Islamic Jihad](#) (PIJ)—praised a wave of vehicular attacks and called for more. One such image posted online read, “Run [them] over, son of Hebron...and son of Jerusalem. Take your car...and run over the Zionists.”⁵²

Recent Vehicular Terrorist Attacks

Terrorists have carried out attacks using cars and trucks in a wide range of countries, including the United States, United Kingdom, France, Canada, China, Germany, Israel, and Belgium. In some cases, assailants have used gas canisters or other explosives to supplement the potential damage from car-ramming attacks. This type of planning could be seen in the June 2007 Islamist attack targeting Glasgow Airport in Scotland,⁵³ the May 2014 attack in China’s Xinjiang province,⁵⁴ and the June 2015 attack on a gas plant in southern France.⁵⁵

In other cases, extremists have managed to launch deadly or harmful vehicular attacks using low-sophistication tactics like car-ramming and stabbing. CEP has documented more than four dozen vehicular terrorist attacks since 2000. Of these, the single deadliest attack was the July 2016 Bastille Day attack in Nice, when terrorist assailant Mohamed Lahouaiej-Bouhlel killed 86 people and wounded 434 more at Nice’s Promenade Des Anglais.⁵⁶

- **March 4, 2006:** North Carolina, United States. Iranian-born Mohammed Reza Taheri-azar uses an SUV to ram into pedestrians at the University of North Carolina, wounding nine people.⁵⁷ Taheri-azar tells investigators that he carried out the attack in order to punish the U.S. government and “avenge the deaths or murders of Muslims around the world.”⁵⁸

- **June 30, 2007:** Scotland, United Kingdom. Terrorists drive a flaming jeep into the entrance of Scotland's Glasgow Airport, wounding five people.⁵⁹
- **2008—Present:** West Bank. Assaultants carry out more than two dozen vehicular terrorist attacks targeting Israeli civilians and soldiers in the West Bank since 2008. The attacks collectively leave dozens of people wounded and at least one person dead.⁶⁰
- **July 2, 2008:** Jerusalem, Israel. Assaultant rams a front-end loader into buses and cars in Jerusalem, killing three people and wounding 40 others.⁶¹
- **July 22, 2008:** Jerusalem, Israel. Assaultant rams a bulldozer into nearby vehicles in Jerusalem, wounding at least 16 people.⁶²

- **September 22, 2008:** Jerusalem, Israel. Assailant rams his car into a group of Israelis in Jerusalem, injuring 15 Israeli soldiers and four civilians.⁶³
- **March 5, 2009:** Jerusalem, Israel. Assailant uses a bulldozer to ram into an Israeli police car in Jerusalem, injuring two officers.⁶⁴
- **August 29, 2011:** Tel Aviv, Israel. A suspected Hamas member drives a stolen taxi into a police checkpoint outside of a Tel Aviv nightclub filled with teenagers before exiting the vehicle and stabbing pedestrians. Nine people are wounded in the attack, including four police officers.⁶⁵
- **May 22, 2013:** London, United Kingdom. Two British-born assailants—[Michael Adebolajo](#) and [Michael Adebowale](#)—ram a car into British soldier Lee Rigby before attacking and killing him with knives and a meat cleaver.⁶⁶
- **May 23, 2014:** Xinjiang, China. Assailants ram two SUVs into a street market and throw explosives in Urumqi, the capital of China's Xinjiang province, killing 39 people and injuring more than 90 others.⁶⁷
- **August 4, 2014:** Jerusalem, Israel. Assailant plows a construction tractor at pedestrians, killing one person and wounding five others.⁶⁸
- **October 20, 2014:** Quebec, Canada. Canadian-born ISIS supporter Martin Couture-Rouleau rams a car into a group of soldiers at a shopping center in Quebec, killing one soldier and wounding another. During the attack, Couture-Rouleau instructed a 911 dispatcher “to alert Canada, the governor and everyone who is responsible for the army” to leave the anti-ISIS coalition.⁶⁹

- **October 22, 2014:** Jerusalem, Israel. A suspected Hamas member rams his car into a crowd of pedestrians at a light rail train station in Jerusalem, killing two people—including a three-month-old girl—and wounding seven more.⁷⁰
- **November 5, 2014:** Jerusalem, Israel. Assailant with alleged ties to Hamas drives into a crowded area in Jerusalem and continues to attack pedestrians using a metal pipe, killing three people and wounding 13 others. Hamas and PIJ both praise the recent wave of vehicular attacks and call for more.⁷¹
- **December 21, 2014:** Dijon, France. A man rams his car into crowds in the eastern French city of Dijon while shouting “Allahu Akbar,” injuring 13 people.⁷²
- **December 22, 2014:** Nantes, France. A man rams a van into a crowd of pedestrians at a Christmas market in Nantes, western France, killing one person and wounding 10 others.⁷³
- **March 6, 2015:** Jerusalem, Israel. Assailant rams his car at border police in Jerusalem, wounding four policewomen and one pedestrian, before exiting the vehicle wielding a meat cleaver. Hamas spokesman [Sami Abu Zuhri](#) posts a statement on Facebook praising the attack on behalf of the terrorist group and calling it “historic.”⁷⁴
- **April 15, 2015:** Jerusalem, Israel. Assailant rams his car into a bus stop in Jerusalem, killing one person and wounding another.⁷⁵
- **June 20, 2015:** Graz, Austria. Assailant rams into a crowd of pedestrians before exiting the vehicle and stabbing passersby, killing three people and wounding three dozen more.⁷⁶

- **June 26, 2015:** Lyon, France. Assailant Yassin Salhi decapitates his boss and drives his van into a gas plant where he worked in Lyon, southern France, lobbing gas cylinders, causing an explosion, and wounding two people.⁷⁷
- **October 13, 2015:** Jerusalem, Israel. Assailant rams his car into a bus stop in Jerusalem before exiting the vehicle and stabbing pedestrians, killing one person and wounding two others.⁷⁸
- **January 1, 2016:** Valence, France. Assailant drives his car into a group of French soldiers guarding a mosque in Valence, southern France, injuring one person.⁷⁹
- **July 14, 2016:** Nice, France. Tunisian-born [Mohamed Lahouaiej-Bouhlel](#) carries out the Bastille Day attacks in France, killing 86 people and wounding 434 more. ISIS claims responsibility.⁸⁰
- **September 29, 2016:** Vienna, Austria. Assailant drives his car at shoppers in Vienna's Favoriten district while shouting "Allahu Akbar," leaving no injuries.⁸¹
- **November 28, 2016:** Ohio, United States. Somali-born [Abdul Razak Ali Artan](#) carries out the car and knife attack at Ohio State University, wounding 11 people. Prior to the attack, Artan calls al-Qaeda propagandist [Anwar al-Awlaki](#) "our hero" in a message posted to Facebook. ISIS claims responsibility.⁸²
- **December 19, 2016:** Berlin, Germany. Tunisian-born Anis Amri carries out the Christmas Market attack in Berlin, killing 12 people and wounding 56 others. ISIS claims responsibility.⁸³
- **March 22, 2017:** London, United Kingdom. British-born [Khalid Masood](#) carries out a car-ramming and stabbing attack, killing five people and wounding 50 others. Masood first rams a crowd of pedestrians on London's Westminster Bridge, killing four people and

wounding dozens more. Masood then crashes his car into the gates of the Palace of Westminster. He stabs to death a police officer outside the nearby Houses of Parliament before being shot and killed by police. ISIS claims responsibility.⁸⁴

- **March 23, 2017:** Antwerp, Belgium. A man is intercepted while driving at high speed toward crowds at De Meir, the major shopping street in Antwerp.⁸⁵
- **April 7, 2017:** Stockholm, Sweden. An assailant drives a truck into a crowd at a shopping mall in Stockholm, killing four people and wounding 15 more.⁸⁶
- **June 3, 2017:** London, United Kingdom. Three assailants drive a van at high speed into crowds on the London Bridge and exit the vehicle to stab other pedestrians at the nearby Borough Market. The attack leaves at least eight people dead and least 48 others wounded. The attackers are later identified as Youssef Zaghba, Khuram Butt, and Rachid Redouane.⁸⁷
- **June 19, 2017:** London, United Kingdom. An assailant drives at a crowd of worshipers near a mosque in north London, leaving at least eight people wounded.⁸⁸
- **June 19, 2017:** Paris, France. An armed assailant rams his vehicle at a police car on the Champs-Élysées street in Paris, seriously injuring himself but leaving no other casualties.⁸⁹
- **August 17, 2017:** Barcelona, Spain. A van is deliberately driven into a crowd of tourists in Las Ramblas, a tree-lined street in the center of Barcelona. The attack, claimed by ISIS, leaves 16 people dead and 120 others wounded.⁹⁰

- **September 30, 2017:** Edmonton, Canada. A Somali assailant is suspected behind two vehicular attacks, collectively injuring five people. In the first attack, the assailant uses a car to ram into a police officer before exiting the car and stabbing him. The assailant later uses a truck to ram into pedestrians, injuring another four people. An ISIS flag is later found in the suspect's vehicle.⁹¹
- **October 31, 2017:** New York, United States. Uzbek immigrant Sayfullo Saipov drives a rented Home Depot truck onto a bicycle path along New York City's West Side Highway for approximately 20 blocks. The driver strikes several people before he drives into a school bus. Police shoot and arrest the driver after he exits the truck carrying a paintball gun and a pellet gun. At least eight people are killed and at least 12 are wounded. Mayor Bill de Blasio calls the attack "an act of terror." It is the deadliest terror attack in New York since 9/11. Police find handwritten notes near the truck attributing the attack to ISIS, and Saipov is reportedly linked to social media accounts that posted ISIS-related material.⁹²
- **November 17, 2017:** West Bank. A 17-year-old Palestinian attacker drives a car into a 70-year-old pedestrian at the Efrat South Junction near the Israeli settlement of Efrat. The attacker then continues to the nearby Gush Etzion Junction where he strikes a 35-year-old pedestrian. The attacker exits his vehicle and attempts to stab an Israeli soldier, who shoots and wounds the attacker. Both pedestrians are wounded but survive. The attacker is arrested.⁹³
- **March 16, 2018:** West Bank. Alaa Rateb Aa-Latif Kabha drives a car into a group of soldiers outside the Mevo Dotan settlement in the northern West Bank, killing two soldiers and wounding two others. Kabha is detained and taken to a hospital with injuries. The Israeli military labels the ramming a terrorist attack. Hamas praises the attack but does not claim credit.⁹⁴
- **August 14, 2018:** London, United Kingdom. A man drives his car into bicyclists and pedestrians during morning rush hour in London before crashing into security barriers

outside the Houses of Parliament, wounding three. Police label the incident an act of terrorism and arrest the driver, whose identity is not immediately revealed.⁹⁵

- **August 20, 2018:** Grozny, Chechnya. A man attempts to run over a police officer with his car and instead wounds two other officers before he is killed. ISIS claims responsibility.⁹⁶
- **November 26, 2018:** West Bank. Ramzi Abu Yabes drives his car into a group of soldiers on a sidewalk along the Route 60 highway near the Karmeit Tzur settlement, wounding three. The driver is shot dead.⁹⁷
- **January 1, 2019:** Germany. A 50-year-old German man rams his car into two groups of New Year's revelers shortly after midnight in the city of Bottrop and then again in Essen, wounding eight people, including a 4-year-old boy. Seven of the victims are from Syria and Afghanistan. The eighth victim is identified as a German-Turk from Essen. The driver is charged with multiple counts of attempted murder and is suspected of carrying out a hate crime after telling police he wanted to kill foreigners.⁹⁸
- **March 4, 2019:** West Bank. A car drives into a group of soldiers on the side of the road at the entrance to the village of N'ima near Ramallah, injuring two. The soldiers open fire at the three occupants in the car, killing two and wounding the third. Soldiers find Molotov cocktails in the car. The two slain attackers are identified as Amir Daraj and Yousef Inqawi. The wounded attacker is not publicly identified. Hamas praises the attack.⁹⁹
- **August 19, 2019:** West Bank. A car hits two teenage siblings at a bus stop outside the Elazar settlement in the central West Bank, wounding both, one seriously. The vehicle rolls over after the attack and police shoot the driver dead as he tries to exit. The driver is

identified as 26-year-old Ala'a Harimi of Bethlehem. The car he was driving had been reported as stolen. Hamas praises the attack.¹⁰⁰

- **September 20, 2019:** Illinois, United States. Javier Garcia drives his SUV through the front entrance of a Sears store at the Woodfield Mall in Schaumburg, Illinois, wounding seven people. State authorities charge Garcia with terrorism and criminal damage to property. Authorities do not immediately determine a motive. Garcia suffers from schizophrenia, paranoia, and bipolar disorder and accidentally drove through the mall because of his mental illness, according to Garcia's attorney.¹⁰¹
- **October 22, 2019:** Oslo, Norway. An armed man steals an ambulance and drives it into a crowd, wounding three, including 7-month-old twins. The hijacker is wounded in a firefight with police who then arrest him and charge him with attempted murder. A woman at a nearby shopping center is also arrested in connection with the attack on a charge of illegal possession of a firearm. Police find a shotgun and an Uzi machine gun at the scene where the ambulance was stolen. Authorities do not immediately identify a motive for the attack. The attacker reportedly had previously distributed propaganda for the Nordic Resistance Movement, raising suspicion of a far-right motive, though he allegedly did not belong to the group.¹⁰²
- **December 31, 2019:** Magas, Ingushetia. Two armed men strike a police officer with their car and then attack three other officers with knives, altogether wounding four before one of the attackers is shot dead and the other is wounded. ISIS claims responsibility.¹⁰³
- **February 6, 2020:** Jerusalem, Israel. An assailant rams his car into a group of Israeli soldiers standing outside an entertainment complex, wounding 12. Police recover the car hours later in Bethlehem in the West Bank and shortly after arrest the suspect, identified as 24-year-old Khaled al-Tourman. Hamas praises the attack as a response to U.S. President Donald Trump's peace plan.¹⁰⁴

- **April 22, 2020:** West Bank. A van strikes a border policeman at a checkpoint near the Israeli settlement of Maale Adumim. The driver then exits the van and stabs the officer with a pair of scissors, wounding him. The attacker is shot and killed by police. The Palestinian Authority identifies the attacker as 25-year-old Ibrahim Halaseh.¹⁰⁵
- **April 27, 2020:** Colombes, France. A 29-year-old Frenchman drives his car into a group of police cars and motorcycles in the Paris suburb, injuring three officers. The suspect is arrested at the scene. While searching the suspect's car, police find a knife and a letter pledging loyalty to ISIS. Police identify the attacker as Youssef T. He reportedly tells police he was inspired by watching videos about Palestine and the Gaza Strip.¹⁰⁶
- **May 14, 2020:** West Bank. A Palestinian man strikes an Israeli soldier with his car at a military observation post near the West Bank settlement of Negohot near Hebron, wounding the soldier. Nearby soldiers shoot and wound the attacker, who later dies of his wounds.¹⁰⁷
- **June 23, 2020:** West Bank. A Palestinian man attempts to ram his car into an Israeli checkpoint in the east Jerusalem suburb of Abu Dis. One Israeli soldier is wounded. The attacker is shot and killed.¹⁰⁸
- **August 18, 2020:** Berlin, Germany. A 30-year-old Iraqi man crashes his car into other vehicles on the A100 highway in Berlin, injuring six people. The man later stops on the road and places an ammunition crate on top of his car, claiming the box is filled with explosives. Witnesses report the man shouted "Allahu akbar" as he got out of the car. Police apprehend the man and find only tools inside the crate. Berlin authorities call the incident a deliberate Islamist-motivated attack.¹⁰⁹
- **December 1, 2020:** Trier, Germany. A 51-year-old man identified as Bernd W. drives an SUV through a pedestrian area, killing at least five and wounding 15 others. Police stop the vehicle after about a kilometer and arrest the driver. The driver intentionally drove into the pedestrians, according to police. Authorities do not immediately identify a motive, but they investigate on the assumption the driver was not politically or religiously

motivated. Police determine the driver had a blood alcohol level of 1.4 as well as “indications of psychological illness.” Police believe the attacker acted alone.¹¹⁰

- **April 2, 2021:** Washington, D.C. A suspect later identified as Noah Green drives a sedan into two U.S. Capitol police officers at a barricade outside of the Capitol Building, wounding both officers. Green then emerges from the car brandishing a knife and is shot by Capitol police. Both Green and one of the officers die from their wounds after they are transported to a nearby hospital. Shortly after the attack, the acting chief of the Metropolitan Police Department says the attack did not appear to be terrorism related but an investigation is ongoing. Green’s social media reveals he was a follower of the Nation of Islam and its leader, Louis Farrakhan, who is accused of promoting anti-Semitism and racism. Green’s family and friends say prior to the attack he was suffering from issues such as hallucinations, heart palpitations, headaches, and suicidal thoughts, which could have stemmed from drug use or mental illness.¹¹¹
- **May 16, 2021:** Jerusalem, Israel. An east Jerusalem resident drives his car into a police checkpoint in the Sheikh Jarrah neighborhood, wounding seven. The driver is shot and killed. Sheikh Jarrah is a flashpoint for recent violence as the Israeli supreme court debates the eviction of a group of Arab residents, sparking Arab-Jewish violence across the country.¹¹²
- **June 6, 2021:** London, Ontario, Canada. Nathaniel Veltman jumps a curb with his pickup truck and strikes a Muslim family of five, killing four and wounding one. He drives off but is arrested soon after and charged with four counts of first-degree murder and one count of attempted murder. Police say there is evidence the attack was planned and premeditated and Veltman targeted the family because they were Muslim. Canadian Prime Minister Justin Trudeau calls the incident a “terrorist attack” and pledges to combat far-right groups and online hate.¹¹³

- **June 16, 2021:** West Bank. A Palestinian woman identified as Mai Afanah attempts to run over a group of Israeli soldiers in the town of Hizma, wounding one. Afanah exits her vehicle and attempts to stab other soldiers before she is shot and killed. Hours before the attack, Afanah reportedly wrote on Facebook, “I don’t have much time left in life.”¹¹⁴
- **October 14, 2021:** West Bank. A 22-year-old Palestinian man drives his vehicle into a group of Israeli border police officers evacuating an illegal settlement in Kalandiya, striking and injuring one officer before crashing his vehicle into a wall. Israeli police arrest the driver.¹¹⁵
- **December 13, 2021:** West Bank. A 15-year-old Palestinian boy identified as Mohammed Younes drives his vehicle into an Israeli army checkpoint south of the city of Tulkarem, injuring one security guard. The boy is killed when other guards open fire.¹¹⁶
- **January 11, 2022:** West Bank. A Palestinian man identified as Muhammad Nazmi Yassin drives his vehicle into a group of Israeli soldiers outside the Neveh Tzuf settlement, wounding one. Yassin is arrested. Palestinian media share videos and photos of the attack and the arrest.¹¹⁷
- **March 22, 2022:** Beersheba, Israel. An Israeli Bedouin man identified as Muhammad Alab Ahmed abu Alkiyan stabs a woman at a gas station and then returns to his car and proceeds to run over a bicyclist at a nearby shopping center. The attacker then exits his vehicle and attacks passersby with a knife, wounding two. A passerby shoots and kills the assailant. At least four people are killed in the attack. Hamas and Palestinian Islamic Jihad praise the attack but do not claim responsibility.¹¹⁸
- **October 30, 2022:** West Bank. A Palestinian man drives his vehicle into Israeli soldiers at two locations south of the West Bank city of Jericho, injuring five of them before

being shot dead. He first strikes a group of soldiers at Nabi Musa before ramming his vehicle into a bus stop at the Almog Junction where he is shot and killed.¹¹⁹

- **November 2, 2022:** West Bank. A Palestinian man identified as Habas Rayan strikes an Israeli soldier at a West Bank checkpoint near the Israeli town of Modiin, wounding the soldier. Video footage shows Rayan exit his vehicle fter hitting the soldier and attempt to attack the soldier with a pickax before the soldier shoots him dead. According to media reports, two of Rayan’s son have served prison time for terror offenses.¹²⁰
- **November 24, 2022:** Beershesheba, Israel. Amr Alkirnawi, a resident of the Bedouin-majority city of Rahat, drives onto a sidewalk in Beersheba, striking and wounding a teenage college student. The driver flees the scene but is quickly arrested. The driver says he lost control of his vehicle and says it was an accident. Authorities later label the incident a terror attack. Alkirnawi is indicted on December 12 and charged with charged with a terrorist act of attempted murder, aggravated assault, and illegal use of a vehicle.¹²¹
- **December 8, 2022:** Tel Aviv, Israel. Ali Hamad rams his vehicle into a man on a motorcycle, wounding the rider. Hamad is arrested shortly after. Police initially label the incident a traffic accident but later redesignate it as a terror attack after Hamad confessed to carrying out the attack in revenge for his cousin, Mojahed al-Najjar, who died after attacking a West Bank Israeli military post on December 7. Hamad had entered Israel illegally.¹²²
- **December 23, 2022:** Kfar Qassem, Israel. 20-year-old West Bank resident Naim Badir calls an emergency police line in the middle of the night to report a false domestic violence incident. When police arrive, Badir runs out of the house with a makeshift machine gun, which jams when he attempts to fire at the police. He runs back into the building and throws Molotov cocktails at the police. Badir then runs to his car and attempts to run over the officers, wounding three. Police shoot and kill Badir. Police label the incident a terrorist attack, which the family denies.¹²³

- February 10, 2023:** Jerusalem, Israel. Israeli citizen and east Jerusalem resident Hussein Qaraq drives a Mazda sedan into a bus stop in east Jerusalem's Ramot neighborhood, killing at least three and wounding four others. Qaraq is shot dead by a police officer who happened to be on the scene. The attack immediately kills a 20-year-old student and a 6-year-old boy. The 6-year-old's 8-year-old brother dies from his injuries the following day. Hamas and PIJ praise the attack but do not claim responsibility. A senior Israeli official tells the Times of Israel Qaraq was mentally ill and was released from a hospital in Tel Aviv a few days before the attack. According to his uncle, Qaraq had been hospitalized for a back injury. Police label the incident a terror attack. A review of Qaraq's Facebook page reveals posts praising attacks against Israeli soldiers and civilians, as well as praising PIJ leader Ziad al-Nakhalah. Police reportedly arrest Qaraq's wife, father, and brother. The Israeli government orders the demolition of Qaraq's house.¹²⁴

Vehicle Attacks Against Protesters

Vehicle attacks have been associated with Islamist terrorism as a tactic of groups such as ISIS, al-Qaeda, and Hamas. Since 2016, however, vehicular attacks against protesters have risen.¹²⁵ Authorities recorded at least 50 vehicular rammings against protesters between May and June 2020. Officials classified at least 18 of those as deliberate attacks.¹²⁶ Between May 27 and September 5, 2020, there were at least 104 incidents of people driving vehicles into protests.¹²⁷ While many of these intentional attacks appear attributable to those subscribing to far-right ideologies, some were also perpetrated by those on the left against right-wing protesters. In other cases, police vehicles drove through protester crowds when surrounded.¹²⁸

CEP examined a sample of 24 vehicular attacks against protesters since 2016, which wounded at least 73 and killed at least two.

The utilization of vehicle rammings in protests by both the right and the left dates to at least 2016 with street protests against the Dakota Access Pipeline, a 1,172-mile-long underground oil pipeline in the United States. Advocates for Native American rights protested the pipeline's encroachment on tribal lands and the hazardous ecological and health effects of possible leaks.¹²⁹ During a protest on October 10, 2016, in Reno, Nevada, 18-year-old Nicholas Mahaffey injured four people after driving his pickup truck through a group of demonstrators. Witnesses recorded Mahaffey antagonizing protesters before the collision and called the attack a hate crime. Mahaffey later pled guilty to provoking an assault.¹³⁰ Later that month, protesters Michael Fasig of Minnesota and Israel Hernandez rammed their vehicles into a private security officer's truck during protests against the Dakota Access Pipeline in North Dakota. The pair reportedly did not recognize the driver as a security officer and believed he posed a threat to the protesters. Fasig and Hernandez both pled guilty to counts of menacing and criminal mischief.¹³¹

The use of vehicle rammings during protests gained national attention after the Unite the Right rally in Charlottesville, Virginia, on August 12, 2017. James Alex Fields drove his car into a group of people, wounding 30 and killing one. He later pled guilty to 29 of 30 hate crime charges and is sentenced to life in prison.¹³² Fields's attack was not random. He targeted the protesters because of their opposition to the far-right rally.

The far right has since encouraged vehicle attacks against protesters by dehumanizing and objectifying protesters in online propaganda. Ultimately, this propaganda appears designed to

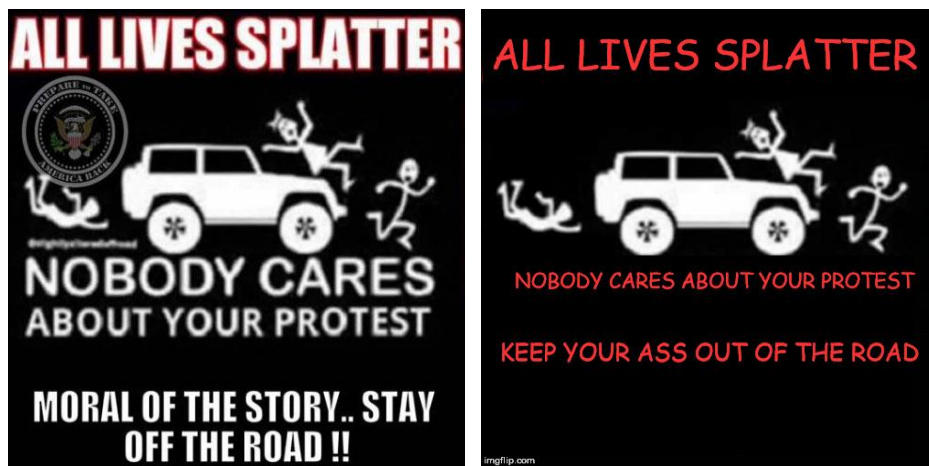

delegitimize the protests, which broadly support values anathema to the far right such as racial equality and the Black Lives Matter movement specifically. Online memes promote the perversion of the “Black Lives Matter” slogan into “All Lives Splatter,” with depictions of cars driving into protesters. Other memes portray protesters as deserving of being hit by cars while demonstrating in the streets and creating inconveniences to non-protesters. For example, memes in this category praise the idea of running over protesters to avoid being late to work. There is also an attempt to normalize the idea that protesters should expect to be struck by vehicles when protesting in the streets. Multiple memes in this category use celebrity images to express faux shock that protesters are hit by cars while standing in the street. Others revel in hitting demonstrators or portray vehicles covered in blood while proclaiming the drivers encountered speed bumps but did not see any protesters.



“All Lives Splatter” meme mimic the slogan Black Lives Matter.



Another set of memes glorifies vehicular attacks against protesters through the delegitimization of protesters' lives. These memes portray the message that they deserve to be victims of violence for demonstrating on streets and highways.

These memes not only delegitimize the reasons behind the protests, they broadly encourage violence against protesters by characterizing them as inconveniences. Thus, whether the protesters are demonstrating for racial justice, the environment, or any other cause becomes inconsequential. These memes shift the focus from the specific cause to the objectification of the protesters themselves.

While the far right have created a paradigm of memes glorifying vehicular attacks, the far left have also adopted the vehicle ramming tactic during protests.¹³³ On September 26, 2020, for example, a reportedly pro-Donald Trump group of counter-protesters began rallying against a Black Lives Matter demonstration in Yorba Linda, California. One of the Black Lives Matter protesters, Tatiana Turner of the car-based protest movement Caravan4Justice, struck and injured two counter-protesters with her vehicle.¹³⁴

At least 39 people were charged for ramming attacks between May 27 and September 5, 2020. According to Ari Weil, a terrorism researcher at the University of Chicago's Project on Security and Threats, just more than 40 percent of 107 ramming incidents recorded in that timeframe were malicious.¹³⁵ In other cases, protesters attacked cars and drivers were exculpated after authorities determined they were acting in self-defense while attempting to escape violence. This was the case on May 30, 2020, when Travis Mixon drove through a group of Black Lives Matter protesters in Tallahassee, Florida. While several protesters were reportedly injured, prosecutors determined Mixon acted in self-defense while trying to escape the protest.¹³⁶

Protests against police brutality spread nationwide in 2020, spurred by the May 25 death of George Floyd in custody. Some of the protests have been marred by violence during widespread rioting and looting. On May 30, 2020, suspect Anthony Knapp allegedly drove his Chevrolet sedan into three police officers and a bystander during a protest against police brutality. Knapp's motives were not immediately clear but the investigation marked one of the first into attacks on police

during protests.¹³⁷ Police vehicles have also been involved in ramming attacks on protesters. Between May and September 2020, at least eight rammings were attributed to police officers.¹³⁸ After two police cruisers struck protesters in Brooklyn, New York, on May 29, 2020, New York City Mayor Bill de Blasio blamed the incident on “a group of protesters blocking and surrounding a police vehicle, a tactic that we had seen before in the last few days, a tactic that can be very, very dangerous to everyone involved.”¹³⁹

Recent Vehicle Attacks Against Protesters

- **October 10, 2016:** Reno, Nevada. A driver in a pickup truck with a 17-year-old passenger approaches a group of 40 people protesting Columbus Day and the Dakota Access Pipeline with a Native American rights group. The crowd encircles the truck and the driver begins arguing with the protesters. He then drives through the crowd, wounding four. Protesters call the attack a hate crime. Police arrest the suspected driver, 18-year-old Nicholas Mahaffey, on charges of provoking an assault. No vehicular charges are made because the protesters threatened and punched Mahaffey and his passenger after Mahaffey initially stopped the vehicle at the protest. Mahaffey pleads not guilty. Two others, James Fletcher and Samuel Harry, are arrested on misdemeanor simple battery charges. In February 2017, Mahaffey pleads guilty to provoking an assault and is sentenced to 14 weeks of anger management and 120 hours of community service.¹⁴⁰
- **October 27, 2016:** Morton County, North Dakota. Protesters Michael Fasig of Minnesota and Israel Hernandez of New York ram their vehicles into a private security officer’s truck during protests against the Dakota Access Pipeline in North Dakota. Kyle Thompson was reportedly disguised as a protester and Fasig and Hernandez allegedly did not know he worked for the security company. The pair reportedly believed Thompson posed a threat

to the protesters. Fasig and Hernandez are charged with reckless endangerment and criminal mischief. In October 2017, Fasig and Hernandez plead guilty to lesser misdemeanor counts of menacing and criminal mischief in exchange for dismissing the felony charges. They are ordered to pay fines and Hernandez is ordered to complete community service.¹⁴¹

- **August 12, 2017:** Charlottesville, Virginia. James Alex Fields drives his car into a group of people protesting the Unite the Right rally in Charlottesville, wounding 30 and killing one. He later pleads guilty to 29 of 30 hate crime charges and is sentenced to life in prison.¹⁴²
- **May 28, 2020:** Denver, Colorado. A woman drives a black SUV through a crowd of protesters on the street. One man hops on the hood, then falls off when the car accelerates, video shows. The car then turns and hits the man, who is knocked down. The woman drives away, and protesters chase the car on foot. Police search for the driver. In July, authorities charge Jennifer Watson with assault and reckless driving. Her attorney claims Watson was trying to get home when protesters attacked her car.¹⁴³
- **May 30, 2020:** Brooklyn, New York. Two police cruisers drive into a crowd of protesters, sending people sprawling across the street. Protesters claim police then pepper-spray and beat them with batons. New York City Mayor Bill De Blasio calls for investigation but says the situation “was created by a group of protesters blocking and surrounding a police vehicle, a tactic that we had seen before in the last few days, a tactic that can be very, very dangerous to everyone involved.” No are casualties reported.¹⁴⁴
- **May 30, 2020:** Denver, Colorado. During a protest against police brutality spurred by the May 25 death of George Floyd in police custody in Minneapolis, Minnesota, a dark

Chevrolet sedan drives into a patrol vehicle, injuring three police officers and a bystander. Police later identify Anthony Knapp as the driver and arrest him on multiple charges of first-degree assault and attempted assault. According to some reports, Knapp was a protester at the rally but his motives were not immediately clear. The investigation is reportedly among the first opened into attacks on police during protests.¹⁴⁵

- **May 30, 2020:** Tallahassee, Florida. Travis Mixon drives two passengers in a pickup truck into a Black Lives Matter demonstration protesting the death of George Floyd. Mixon revs his engine—admittedly to scare the protesters—and then slowly starts driving through the protesters, causing light injuries. Prosecutors do not file charges after deciding Mixon acted in self-defense while trying to escape the protest.¹⁴⁶
- **May 31, 2020:** Los Angeles, California. Protesters surrounded a police SUV, which accelerates to get away and at the same time strikes and injures two people. The Los Angeles Police Department says the officers were responding to a possible robbery.¹⁴⁷
- **May 31, 2020:** Minneapolis, Minnesota. An 18-wheel semi-truck drives into a crowd of peaceful demonstrators in Minneapolis on Interstate 35, which had been closed to traffic for the protest against police brutality spurred by the May 25 death of George Floyd in police custody. No casualties are reported. Protesters reportedly pull driver Bogdan Vechirko from the truck and he sustains light injuries. Vechirko is arrested on suspicion of assault, but he is later released without charges after officials conclude he did not intend to cause harm. An online petition to have Vechirko charged gathers more than 52,000 signatures.¹⁴⁸
- **June 2, 2020:** Queens, New York. Frank Cavalluzzi of Queens puts on a glove with four long, serrated-edge blades and begins chasing Black Lives Matter protesters in Queens' Whitestone neighborhood. Cavalluzzi then gets into his SUV and drives onto the sidewalk to chase protesters while shouting "I will kill you." The attack is captured on camera from several angles. Cavalluzzi is arrested two days later after he surrenders to the police. He is

charged with multiple counts of attempted murder, attempted assault, reckless endangerment, menacing, endangering the welfare of a child, and criminal possession of a weapon.¹⁴⁹

- **June 6, 2020:** Pensacola, Florida. A Ford Flex SUV drives into a group of Black Lives Matter protesters blocking traffic on the Bayfront Parkway. One protester, Jason Uphaus, throws himself on the hood of SUV, which carries him for the entire length of the bridge before the police stop the vehicle. Uphaus calls for charges to be filed against the driver. Uphaus is arrested on July 2 and charged with disorderly conduct and criminal mischief. The charges are later dropped after Uphaus filed a Stand Your Ground motion against the SUV driver.¹⁵⁰
- **June 7, 2020:** Richmond, Virginia. Harry H. Rogers drives his pickup truck through a crowd of Black Lives Matter protesters in the roadway, wounding three. Rogers is reportedly an admitted Ku Klux Klan leader. In August, Rogers is convicted on six counts of assault, destruction of property, and hit-and-run charges. He is sentenced to six years in prison.¹⁵¹
- **June 28, 2020:** Detroit, Michigan. Protesters demonstrating against racism and police brutality surround a police SUV and begin to climb on top of it. The police vehicle proceeds to accelerate through the crowd and strike at least 10 protesters as it leaves the scene. Detroit Police Chief James Craig praises the officers for doing “the right thing” to escape the situation.¹⁵²
- **July 4, 2020:** Seattle, Washington. Dawit Kelete allegedly drives his Jaguar car the wrong way onto an exit ramp onto a closed section of the Interstate 5 freeway where a Black Lives Matter is taking place. The vehicle strikes two protesters who were walking on the highway’s shoulder. The Jaguar reportedly continues driving for one mile until protesters

force it to stop. One of the victims dies in the hospital that night. Kelete is arrested on charges of vehicular manslaughter and pleads not guilty.¹⁵³

- **July 6, 2020:** Long Island, New York. Anthony Cambareri of Coram, Long Island, allegedly slows down as he drives his Toyota RAV4 toward a Black Lives Matter protest in Huntington Station and then speeds up to drive through the protest, wounding one. Cambareri drives away as protesters chase his car. Police pull Cambareri over and arrest him. He is charged with third-degree assault. A second protester claims initially he had also been hit but then recants.¹⁵⁴
- **July 6, 2020:** Bloomington, Indiana. A driver of a Toyota Corolla approaches an anti-racism protest as it begins to disperse. The driver and a passenger reportedly step out of the vehicle to remove an electric scooter from the road and protesters surround the car. The driver allegedly revs her engine and drives into the large crowd, injuring two before driving away. Two days later, police arrest suspected driver Christi Bennett on charges of criminal recklessness and leaving the scene of an accident.¹⁵⁵
- **July 7, 2020:** New York, New York. A black Dodge Durango SUV approaches a group of Black Lives Matter protesters demonstrating at an intersection near Times Square. Protesters surround the vehicle and pound on the windows while yelling at the driver to turn around. According to the New York Police Department, protesters also place bicycles in front of the car to stop the driver from moving forward. The vehicle drives through the protesters, injuring one and reportedly destroying three bicycles. The driver is taken into custody, but no charges are filed.¹⁵⁶
- **September 3, 2020:** New York, New York. A black Ford Taurus drives through a group of Black Lives Matter protesters, injuring five. Two of the victims file a police report against the driver after police say they cannot file charges without one. According to the New York Police Department (NYPD), the vehicle was filled with counter-protesters who were ordered to leave the area that evening prior to the attack. The NYPD was escorting the vehicle from the scene when the Taurus reportedly “missed a turn” and instead drove

into protesters. The incident is caught on video and social media posts identify the driver as Hakim Gibson, a Trump supporter and pro-police activist who had purchased the SUV at a police auction and appeared at other pro-Trump demonstrations in the past. Police interview all six passengers in the car but do not file charges. One of the passengers tells the Associated Press that Gibson had offered to drive the other counter-protesters away out of fear of a growing mob.¹⁵⁷

- **September 23, 2020:** Buffalo, New York. A pickup truck drives into a group of demonstrators protesting against the decision not to indict officers in the death of Breonna Taylor, hitting a protester on a bicycle. Protesters yell at the driver to stop and pound on the truck, which then quickly drives away.¹⁵⁸
- **September 23, 2020:** Denver, Colorado. Protesters demonstrating outside the Capitol Building against the decision not to indict officers in the death of Breonna Taylor surround a Volvo and tell the driver to turn around. The driver instead accelerates and hits one protester before driving away.¹⁵⁹
- **September 24, 2020:** Los Angeles, California. A pickup truck hits one protester in downtown Los Angeles during a protest against the decision not to charge police officers for the death of Breonna Taylor. The protester sustains minor injuries. Later in the evening, a Prius hits a parked Mustang while trying to drive away from the protest. Protesters attempt to pull the driver out of the car, but he escapes. No injuries are reported in the second incident and police detain the driver.¹⁶⁰
- **September 26, 2020:** Yorba Linda, California. Supporters of U.S. President Donald Trump begin a counterprotest during a rally by a group demonstrating for Black Lives Matter and against police brutality. Tatiana Turner of the car-based protest movement Caravan4Justice strikes two counter-protesters with her vehicle. Turner is charged with attempted murder, six counts of assault with a deadly weapon, one count of mayhem, and two counts of illegal use of tear gas.¹⁶¹

- **October 3, 2020:** New York, New York. A black Infinity SUV approaches a group of Black Lives Matter protesters on bicycles participating in a “Justice Ride” in Manhattan’s Flatiron District organized by Street Riders NYC. The SUV’s driver honks at the protesters and speeds up while driving through the group, injuring two. The vehicle drives away. According to Street Riders NYC, the driver had initially parked nearby and engaged in a verbal confrontation with the protesters—including threats of physical violence, insults, and racial epithets—prior to the attack.¹⁶²
- **June 24, 2022:** Cedar Rapids, Iowa. A male driver reportedly rams his truck into a group of women protesting the Supreme Court’s decision to overturn *Roe v. Wade*, wounding at least one. Police reportedly interview the driver, but no arrests are made.¹⁶³

Conclusion:

As the TSA notes, vehicular terrorist attacks are becoming “more commonplace around the globe.”¹⁶⁴ Indeed, terrorists are increasingly relying on low-sophistication tactics like car-ramming and stabbing to kill or injure large groups of people without easy detection or intervention by law enforcement. These assailants often target locations where large numbers of people congregate, particularly on or around major national holidays, when civilians are likely to be outdoors shopping or celebrating.¹⁶⁵ Protests also provide desirable targets because of the large crowds and flaring tempers among both protesters and counter-protesters.

Although there is little that can be done to prevent the weaponization of motor vehicles, the TSA has encouraged bus and trucking companies to be vigilant about indicators—like modifications to vehicles—that may suggest a vehicular terrorist attack. The TSA has also encouraged the use of vehicle barriers to prevent vehicles from accelerating into populated areas, protecting large crowds of people from attacks at outdoor venues like concerts, sporting events, and holiday markets.¹⁶⁶

As CEP notes, far more can also be done by tech companies to counteract calls to violence by groups like ISIS, al-Qaeda, and Hamas, as well as the proliferation of violent memes. In their Terms of Service agreements, Facebook, Twitter, and Instagram all prohibit the promotion of violence or behavior that may cause harm.¹⁶⁷ Nonetheless, memes glorifying and promoting violence against protesters remain easily accessible online across various platforms. After the March 2017 Westminster attack, YouTube was “inundated with violent ISIS recruitment videos,” according to findings by the U.K. government. The British government noted that YouTube failed to block this slew of content, despite the videos being easily searchable and posted under usernames like “Islamic Caliphate.”¹⁶⁸ After the June 2017 London Bridge attack, U.K. Prime Minister Theresa May called for increased regulation on the Internet, where terrorist recruitment and incitement to violence largely takes place remotely.¹⁶⁹ Despite Google’s claims to have improved its takedown efforts, CEP has tracked the appearance and reappearance of major ISIS videos on YouTube (Google’s subsidiary), including those calling for vehicular terrorist attacks. CEP’s findings raise serious questions about Google’s stated commitment to confronting terrorist recruitment using hashing technology, which prevents flagged content from being re-uploaded to a platform.

CEP has tracked the appearance and reappearance of major ISIS videos on YouTube calling for vehicular terrorist attacks. CEP’s findings raise serious questions about the company’s stated commitment to confronting terrorist recruitment on its platform.

In many cases, assailants themselves are active on tech platforms like Google, Facebook, and WhatsApp prior to carrying out an attack. Abdul Razak Ali Artan, perpetrator of the November 2016 Ohio State University attack, called al-Qaeda cleric [Anwar al-Awlaki](#) “our hero” in a message posted to Facebook.¹⁷⁰ Khalid Masood, perpetrator of the March 2017 Westminster attack, sent a message on WhatsApp announcing his intention to wage jihad minutes before launching his assault.¹⁷¹

COUNTER EXTREMISM PROJECT

While it is impossible to prevent all vehicular terrorist attacks, far more can and should be done to reduce the threat. Tech companies, for one, can do far more to prevent groups like ISIS, al-Qaeda, and Hamas from using their platforms to recruit new members and reach their target audiences. These companies can also be more proactive and cooperative with law enforcement about the activity of lone-wolf terrorists on their platforms. Tech companies must also take into consideration the emergence in recent years of propaganda promoting and normalizing vehicular attacks. Although we cannot prevent each and every vehicular attack, efforts to prevent even a few attacks can have the foreseeably large impact of reducing widespread fear and, most importantly, saving lives.
